

To all of the WVSC members:

A contingency of the WVSC Racing Community met in early February and agreed upon the 2014 racing program and schedule. No major changes, with the exception being having one race day per week throughout the race season.

No changes to the following:

- 1. Portsmouth handicap with wind speed factors
- 2. 5-minute start sequence
- 3. Separate starts for keelboat & centerboard fleets
- 4. No courses set through hazard areas
- 5. 3-boat minimum to make a race
- Scoring: Club Championship using race scoring "Percentages of Boats Beaten" per US Sailing and as used 2012 at WVSC. This system automatically encourages participation (no participation bonus needed) and encourages participation outside your comfort zone.
- 7. **Scoring/Participation:** Club Championship Keel & Centerboard a. Throw-outs – 1 race in 7 race participated in.
 - b. Minimum participation to win championship is 8 races and or 35% of all races sailed or whichever is greater.

8. Long Distance Race

- a. 1 Per Month max at R/C option
- b. Any regular race with wind from 190 degree +/-15 degrees
- c. Down to "Dam" and back with optional reaching mark.

Race Schedule:

We will have three series: Spring, Summer and Fall. All races will count towards the club trophy for keel and centerboard boats. The remaining racing schedule is as follows:

a. Saturday Fall schedule will start at 2:00 PM for 2 races. Starting on September 6 - October 25.

Race Committee:

Participating in RC can be a very interesting experience, however, if you have no desire to race, but you don't mind getting out on the water and watching boats complete the course that you laid out...then come on out. We're always looking for an extra hand on the RC boat even if you've not gone through RC training. At this time we have a good portion of the race day RC filled, but still have a few more days that need RC to sign up for the 2014 race committee. We will be holding a race committee seminar this spring. The date and time will be announced at a later date.

Our primary goal is to encourage participation in what we as Sailors/Racers feel is a great sport. It's not a difficult sport and it's fun.

BOG Members Absent: Dave Leiker. Member Guests: Kim Rix, James Rix, Gene Plehal, Terry Lewis, Sharon Lewis, Kathy Malcom, Sid Rousseau, Deb Aschbrenner.

1. Call to Order:

a. Quorum

- b. Opening remarks:
 - Kim Rix Directory Discussion: Clerical questions with regard to final revision of current WVSC handbook. Kim to publish "basic" handbook for annual meeting. NEW, finalized WVSC handbook to be published and distributed in early 2015.
- 2. Meeting Minutes: Approval of Aug. 14, 2014 minutes; APPROVED.
- WVSC Website revision status: BOG approved new website development by Bob & Sheryl Born: Born's to present WVSC web plan.
 - a. Dave has been in contact with Sheryl; Sheryl to develop ideas/proposal to present to BOG when they return to town; Dave plans to have Sheryl attend next BOG meeting; Sheryl to send JPEG screen shots, etc. to begin brainstorming.

8/14: IN PROGRESS; working to get info from our site to move to site Cheryl is working on.

7/10: Sheryl stated that WVSC needs to establish its website "core" objectives. She mentioned that WVSC needs to layout the website foundation and plan for the website designer. She also said the hard part of website is the "copy" on each page and the "copy" should be written in a single voice.

Dave Leiker will head up a website design committee.

Tabled – Dave Leiker absent; need update on status of new website. What needs to happen to finalize new website?

4. Action items from prior meetings:

a. Kubick boat: Research WVSC options on how to move forward with WVSC removing the boat: Email sent, but to date no response. Will need to proceed with more aggressive means to resolve current situation.

Notice sent to on 3/31/14: Mr. Kubick if there is no response within 10 business days WVSC would start legal action. Collecting documentation to commence legal action. Have two more attempts to Mr. Kubick without success.

Randy has made two more attempts to contact Mr. Kubick; still pending.

Have made further attempts to contact Mr Kubick without any success. Will again work on getting necessary documentation pull together to start legal process: Randy/Ernie

8/14: Randy asked if there was someone else on the BOG that would take this item over: Zak said he would work this action.

Zak in contact with private attorney/process server.

- b. Refinish club house floor: Will sch midweek to do the floor repainting: Zak
- c. Post STEP: Spring 2015
- d. Replacement of decking on docks: In process, BOG hired Zak as an independent contractor, who offered to do the deck replacement at the same price (\$4897.00) and use the same quality of materials that we were quoted last.
 - 6/12: First phase complete; 2nd phase bid presented tonight; APPROVED.

8/14: Proposal for 3rd phase; \$8,500 APPROVED.

50% of walkway B dock COMPLETE To begin work on A dock walkway

e. Flotation B dock: Randy gave Brad contact info for Prairie Lake CO Matt Livingston:

Matt Livingston out to club; problem is low on flotation on B dock (potential of floats absorbing water); floats to be removed to check for water absorption/new floats to be tested; possibility of using existing flotation temporarily; possibility of pinning sliding joints on slip finger ends: Will need to inventory what flotation club has that is not being used and use as a temporary fix: Bart

Dock flotation update; one 16 inch float replaced as it had water in it. Another 12 inch float removed did not and was put back on the finger it was supporting. Matt Livingston is supposed to come back out to WVSC to assess B dock flotation issue and gather information for a bid.

8/14: \$1,382.41 to purchase 12 floats from Carolina Waterworks; APPROVED. *Amended to \$1410.41 to include 2 18 inch floats*

f. Independent audit: STEP & WVSC books. Still working on; questioning validity and level of satisfaction among WVSC members; will have more detail next meeting:

Information received from local public auditing firm w/experience with 501(c)(3); \$7,000-\$7,500 potential cost for audit; auditor suggests instead a specified procedure review; auditor willing to look at recent financials and discuss further at no cost; ad hoc committee suggested by Randy: David Bonifield, Sharon Lewis, Gene Nold, Kathy Malcom, John Aschbrenner; awaiting information from 2nd firm to finalize decision: Randy WVSC bank/checking account.

Genee to ask insurance agent about bonds on authorized signers. Continue to address options.

7/10: BOG discussed the different levels of auditing and what's called an 'agreed-upon procedures engagement (AUP)'. A motion was made and approved by the board to take this to the annual meeting and let the members decide if this is an effort where we really want to spend the clubs money.

8/14: Multiple signers for WVSC checking account = \$126.00/annually; can go up to 5 signers on account that would be bonded up to \$10,000.

John A. to add to ad hoc committee list of topics.

8/14: John A. to head; will meet to discuss meeting details

Initial meeting held. Would like to specify check writing procedures "formally" in WVSC handbook. Ad hoc committee to meet again in next few weeks.

g. Rule changes for bubblers: Decide if current verbiage in handbook is appropriate or additional changes are needed. Randy/Genee

Working to formalize specific changes.
