MINUTES SUBJECT TO CORRECTION NOVEMBER 12, 2005

**CALL TO ORDER** Commodore Clark Chambers called the meeting to order at 5pm. He recapped what he felt had been a very good year for WVSC. Notable achievements included a good racing year, a successful STEP racing program, paving of the entry and parking area and enjoyable and well attended social events.

**MINUTES OF 2004 ANNUAL MEETING** The year of the meeting was correct from 2005 to 2004. There being no further corrections or additions, the minutes were approved as corrected.

**COMMITTEE REPORTS** Commodore Chambers asked the chairperson or Board liaison to review the activities of their respective committee during the year. A written report provided to the Board is made a part of these minutes. # Racing Report: An Interview with Ken Rix, WVSC's 2005 Centerboard Champion

It was no surprise to see the name "Rix" atop the standings of the centerboard fleet at the conclusion of the championship regatta. For many people, the only question was, "Will it be Ken, Mary Ann or James?" Ken raced to three first place finishes on the final day of the regatta to overtake son James, the day one leader. On a cold November afternoon, Ken looked back at the regatta and his many years of racing, and shared his thoughts with The Windword (TW).

**TW:** Kyle Brady in his Flying Scot crossed the finish line ahead of you on the first race of day two. What were you thinking when you heard the committee boat's horn as he finished?

**Ken:** I thought he had won. You know, I don't mind losing; at a Snipe regatta in Atlanta I finished consistently in the middle of a large fleet. I do recall thinking that he (Kyle) was faster than I thought he would be. I remember rounding the windward mark after the first leg and thinking that I would catch him on the reach, but he was planing right after the mark rounding and I could never make up ground on him. (It turned out that Ken won the race on corrected time after Portsmouth handicaps were applied.)

**TW:** You are one of the club's most senior racers. When did you start racing?

**Ken:** I started crewing for my dad on his Snipe in 1940; I was ten years old. During the war years, racing was discontinued. But when the war was over, I crewed a lot for my Dad.

**TW:** How did you obtain your racing knowledge and skills? Did you take training courses? Read a lot of racing books?

**Ken:** In the early years I learned a lot from crewing for Dad; he was very good. He taught me a lot of things about racing. Mary Ann and James learned about racing from crewing for me years ago and now James is a better sailor than me. He is better in strong winds, but, on a light day, he gets impatient and frustrated and Mary Ann or I can often beat him. In later years, I picked up a lot of books on racing tactics and sail trim. I also attended some seminars put on by North Sails. The sail makers are a big source of knowledge on how to go fast.

**TW:** What would you recommend to a racing novice as a good way to learn about racing?

**Ken:** Crew for a good racer...you pick up a lot of good tips that way. Some of it probably transfers by osmosis; sailing with a good racer teaches you good technique.



**TW:** What makes you a successful centerboard racer? What gives you your edge?

**Ken:** I'm not good at starts. Only occasionally will I get a good start. My boat goes well upwind if I don't try to pinch as much as many Snipe sailors. I trade higher boat speed for pointing ability. You know it is velocity made good to the windward mark that counts and I've found that, for me, boat speed pays off more. I'm also good on reaches but I don't like going downwind...I'm not as good straight downwind.

**TW:** I noticed on one of the regatta races, as you sailed away from me, that you were really working the tiller. Lots of little steering inputs. What were you doing there?

**Ken:** I was adjusting to the wind gusts. When a gust would hit and the boat would start to heel, I'd steer into the wind to counteract the heel. And when the boat would start to come upright, I'd fall off a bit. It's really an unconscious action, like steering a bicycle. The ideal result is to keep the boat at a constant heel angle with your steering inputs. You know, it takes a long time to develop a true feel for what the boat is doing, but when you do, a lot of actions become instinctive. A really good Snipe sailor would probably counter heeling in gusty winds by working the mainsheet, but I do it with the rudder.

TW: Have you ever tried keelboat racing?

**Ken:** Oh, I've sailed with Mike Hand a few times, crewed for him at long distance races. I've also sailed with James on his big boat.

**TW:** What's the difference for you between centerboard and keelboat racing? Why have you stuck with centerboards all these years?



**Ken:** Well, centerboards or keelboats aside, I like one-design racing most. I'd rather race in a one-design race than a handicap race any day. I think centerboards just fit me better. Their smaller size and weight makes them easier to launch and retrieve; one person can raise the mast and rig the boat. Things happen faster on a centerboard, and I like that. When a keelboat heels and I can't lean over the rail to flatten it, that makes me uncomfortable. It just seems unnatural, somehow.

**TW:** How can WVSC develop new racers and improve its racing program?

**Ken:** The STEP program is a great benefit in that regard, bringing in new young and adult sailors to sailing. The race program that was started this year allows them to emphasize racing more. I'd like to see them continue their racing program and perhaps include one for adults next year in addition to one for the kids. The club might try to offer junior racing as a separate event.

**TW:** Congratulations, Ken, on your '05 club championship and thank you for sharing your thoughts and opinions with us.

**Ken:** You are welcome.

WALNUT VALLEY SAILING CLUB BOARD OF GOVERNOR MEETING MINUTES SUBJECT TO CORRECTION

THURSDAY, NOVEMBER 17, 2005

### **CALL TO ORDER:**

Commodore Clark Chambers called the meeting to order at 7:05pm at the office of Marilyn Kroupa. Board Members present were Pat Boyarski,

Clark Chambers, Marilyn Kroupa, Kathy Malcom, John McCabe, Gene Plehal, David Reynolds, DeAun Warfield and Ron White.

#### APPROVAL OF NOVEMBER MINUTES:

The minutes of the October 13 meeting were reviewed. Boyarski made a motion to approve as presented, seconded by Plehal. Motion carried.

**APPROVAL OF THE NOVEMBER TREASURER'S REPORT:** Treasurer Kroupa stated that the November financial reports and annual summary of financial activity was published in the report to members at the annual meeting on November 12 and is unchanged. The treasurer's report was accepted as presented to the general membership.

**OLD BUSINESS:** Commodore Chambers noted that a member had a mechanical boatlift installed without prior approval of the board as required in the Slip Facilities Regulations. The installation does not conform to current mechanical boatlift installation requirements. After discussion, Chambers stated that he would draft a letter to the member reminding him of the regulations as published in the members' handbook, and the requirement for a deposit and contract after receiving approval of the board for the installation. Chamber said he would state a time limit for applying for approval for the installation and for a request for variance from the regulations.

**NEW BUSINESS:** Election of Officers: Commodore Chambers presented a list of the nominations for consideration. After discussion the following members were elected by acclamation: Commodore–Pat Boyarski, Vice-Commodore–David Reynolds Treasurer–Kathy Malcom Secretary–Steve Mardis.

**Bank Account Resolution:** Motion by White, second by Plehal to change the persons allowed to sign checks on the account at Emprise Bank to Pat Boyarski (Commodore), David Reynolds (Vice-Commodore) and Kathy Malcom (Treasurer). Motion approved.
