WALNUT VALLEY SAILING CLUB BOARD OF GOVERNORS MEETING

Minutes Subject to Correction

THURSDAY, JANUARY 8TH, 2008

Call to Order:

The meeting was called to order at 7:00 pm. All board members were present except for Jerry Brady who was unable to attend.

Approval of December meeting minutes:

A motion to approve the December minutes was made and seconded. The minutes were approved as written.

Treasurer's Report

Ernie Condon presented the monthly financial report and advised the board that a request for membership had been made by David Leiker. He has paid his dues and now awaits approval by the board. A motion to accept David Leiker as a new member was made, seconded and his membership was approved.

Old Business:

- **A.** Commodore Reynolds stated that he was recommending the proposal for slip rental adjustments, discussed at a previous board meeting, again be tabled and referred to the Finance Committee for their recommendations. The subject will be revisited after a recommendation from the committee is received.
- **B.** Ernie Condon reported for the Finance Committee that they are awaiting word from our insurance carrier regarding our insurance rate for 2009 and changes in coverage based on an updated financial valuation. Ernie will report back as soon as the Finance Committee receives and evaluates the report.
- **C.** Debbie Chambers reported that work on the 2009 member's handbook was coming along and the handbook will be ready to give to members earlier than in previous years.
- **D.** Greg Rincker, as the Liaison to the Board for Long-range Planning, presented three items for consideration by the Board. After the Long Range Planning Committee has the information needed to proceed on the projects recommended, Greg will present all of the information to the Board for their consideration and approval. The first project is to provide to all members bumper stickers identifying membership in WVSC. If additional stickers are needed, more will be ordered. Second, as discussed previously, the picnic shelter house needs to be expanded to accommodate the large numbers of people attending our socials. Greg will secure current square footage of the shelter and will present recommendations for expanding the shelter to meet needs. Finally, a recommendation for many of the trees remaining in the lake either be cut off, far enough below the water line, to not be a hazard to boats and, if this is not possible, then to secure some type of reflective material to

the trees so that they are less of a hazard to boats at night. Also included in this project, at Mike Wasson's suggestion, would be the

removal of the tree (on land) just west of the dingy dock as it is a hazard to those pulling their boats out of the water. Greg will contact the appropriate government office to see what will be needed, if anything, to secure permission to proceed. Greg will then report back to the Board for discussion and possible approval.

- **E.** Ken Rix reported that the annual racing meeting for all members will be held on Sunday, Feb.1, 2009, at 2:00 PM, in Rose Hill. A notice was in the January newsletter. Additional information regarding this meeting will be provided in the February Windword.
- **F.** Commodore Reynolds requested Board members continue to work on securing committee chairs for any committees that currently do not have a chair and report back at the February meeting.

New Business:

- **A.** John Ellison advised the board that his committee is in the process of getting a quote for the cost of gravel and surface repair for Dry Storage. Also the fence has been damaged in several places and plans are being made to either replace or repair the areas.
- **B.** The screen door in the club house has broken again. The chairmen of the Activity Center are working on securing a replacement door.
- **C.** Debbie Chambers plans a meeting of the Social Committee (all members are invited to participate) on Saturday, February 07, 2009, at 10:00 AM at Panera Bread on North Rock Road to lay out the 2009 party schedule. A notice will be in the February newsletter.

No member concerns were presented.

Closing Remarks

The February board meeting will be held at the office of Steve Mardis on February 12th, 2009, at 7pm. A motion to adjourn was made, seconded and approved. The meeting adjourned at 8:50 p.m.
