## From the Commodore

As we head to the lake for an afternoon of sailing, some of us look forward to a few hours of relaxing, others are there for racing and many enjoy the camaraderie of being with like minded sailors. Something that we are all mindful of but might get pushed to the back of our mind is safety. Just reading the local paper should remind us that we need to pay attention when we are in and around water.

The WVSC STEP program goes to great length to teach safety on the water and we ought to follow suit with our own conscious approach to being around the water. Here are some items that you all know but might help make for a safer afternoon.

- You should always have approved personal flotation devices readily available on your boat. Don't wait for the need to arise to pull them out. I don't know that the KDWP water patrol has stopped sailboats but they certainly have the right to do so and you should be ready for an emergency or an inspection.
- Our lake has a lot of trees that most of us know to avoid but in high winds or a race situation losing a crew member overboard is extra hazardous if you are near the submerged trees.
- Don't swim alone. Most of the time this isn't a problem because typically someone else is around, but if a problem occurs you might need help and need it right now.
- If you are sailing by yourself, make sure somebody is aware that you are on the water and when you expect to be back. Summer storms can arise quickly - having a friend look out for you from shore might save precious time.
- Children are to be supervised and wear flotation gear when on the WVSC decks and slips. This is common sense, but we do bring visitors to the facility so they, too, should know that this is the rule.
- I'm not your mother, but keep in mind the effects of alcohol on your ability to react or keeping your balance.
- Our dock electrical boxes have GFCT's for your safety and those units are checked annually, but many of us have old ratty extension cords running to our boats for lights or charging of the battery. Check the condition of your extension cords to make sure you are not at risk of a shock. I am guilty and will be taking care of it!

The American's with Disabilities Act (ADA) compliance is in the WVSC concessionaire's agreement with the State and has gotten a lot of attention this year. An inspection of our facility has been completed and the findings will be available soon. It is expected that some changes "must" be completed and some "should" be completed. The KDWP personnel have been great and have already provided ADA compliant picnic tables and have built ramps for the STEP storage buildings. Ironically, it appears that the ramps are not on the "must" list for changes at the WVSC, but you will be seeing other changes being made in the coming months.

# Come Sail with Us

## 2010 SUMMER ADULT SAILING PROGRAM

The Walnut Valley Sailing Club/STEP program is offering two sessions this summer.

We will teach you how to sail in a centerboard boat or a keelboat. We will improve your sailing ability in advanced classes. We also offer Basic Keelboat classes.

So come sail with us this summer for a GREAT time on the water.

Our adult fleet consists of — Catalina 14.2's, Sonar, Catalina 22 and Catalina 25's.

### CLASS STRUCTURE

**Age Prerequisites:** Must be 18 years or older, have an interest in learning to sail and swim 25 yards without a lifejacket (PFD). (May be 15-17 years old if accompanied by an adult).

**Equipment requirements:** Participants are required to provide their own life jacket (PFD) US Coast Guard approved, age-appropriate size and sunscreen, hat and water shoes.

### COURSE CONTENT:

**Basic Sailing Course** - Covers beginning, intermediate and advanced sailing techniques. Boat handling skills, boat related skills, basic rules of the road, safety, weather and nomenclature. Everything you need to know to sail your own boat safely and with confidence.

**Basic Keelboat** - The keelboat course leads you through the essential principles of safe, confident day sailing. It covers basic sailing concepts, boat handling, docking, anchoring, safety and emergencies, weather, basic navigation. The keelboat course requires a minimum of three students per boat.

Prerequisite for Basic Keelboat instruction - you must have the Basic Sailing Course or equivalent sailing experience.

**Schedule:** 3 days per week (Mon. Tues. Thurs.) for 3 weeks, 6 to 9pm. 2 Sessions:

- 1st session: June 14 through July 1
- 2nd session: July 5 through July 22

**Class Size:** 10 students per session

**Cost per Student:** WVSC members-\$25 non-refundable Registration Fee, Plus \$155 class fee, total cost-\$180; Non-members-\$25 non-refundable registration fee Plus \$155 for class fee and \$100 for 1/2 annual WVSC club dues Total cost- \$280. (accompanying Spouse or family member \$180)

**Fee Includes:** USSA "Start Sailing Right" or "Basic Keelboat" instruction manual, instruction, use of a Catalina 14.2 (if checked out) boat for the summer, T-shirt and certificate. Includes a membership to Walnut Valley Sailing Club, which begins at the beginning of class and continues for the remainder of the year.

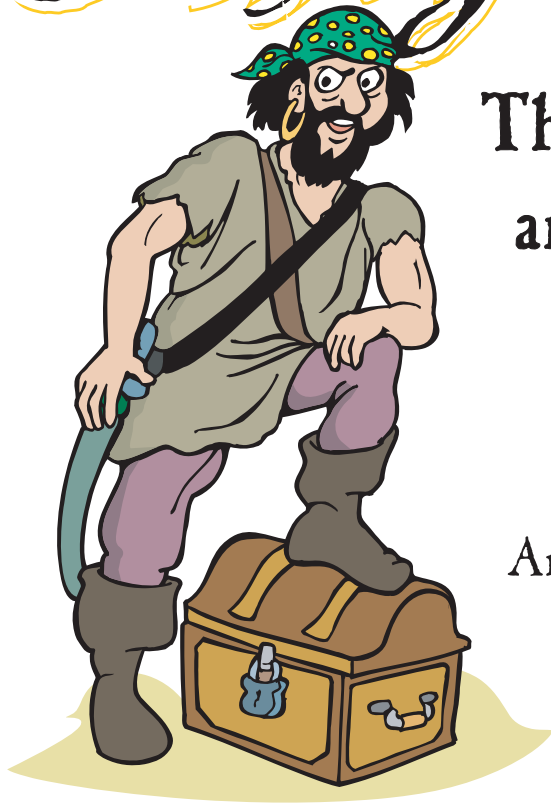

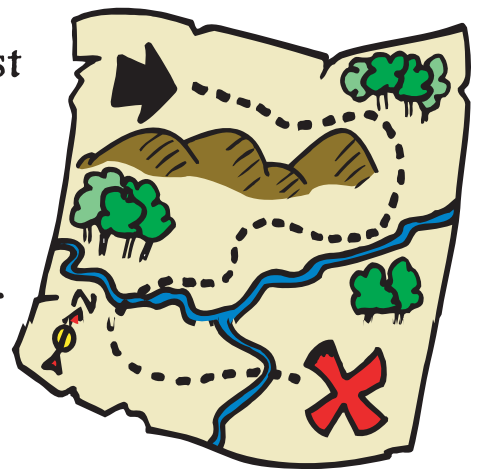

## WALNUT VALLEY SAILING CLUB BOARD OF GOVERNORS MEETING

*Minutes Subject to Correction*

THURSDAY, JUNE 10<sup>TH</sup>, 2010

**Call to order** – opening remarks - 7:04pm. Quorum? – yes.

Corrections to Minutes of May 13, 2010 Board meeting? - None

Minutes from May 25th concessionaire's license meeting – approve?  
**Approved.**

**Treasurer's Report** – May 2010 Provided and reviewed.

Water issues are behind us (had some leaks that resulted in higher bills, but those are history).

Question as to why there were two separate billings for Butler County Treasurer – John McCabe to provide update later.

John McCabe questioning why we are not depreciating the committee boat. Needs to talk to Kathy Malcom for guidance.

24 slips are empty (aligns with forecast/budget, but budget could be much better if we filled the slips).

Cross out misc adjustment for John Cater (has a zero value).

Need to continue to have the treasurer's report come out early for prior review (was not early this month because of new bookkeeper)

**Treasurer's report approved.**

### **Old Business**

Committees – Liaisons and Chair positions and reports

Crack in parking lot: KDWP does not currently know of roadwork plans for the park this year. We will be checking to see if other parts of the State will be in the area and could do the repair for a fee. The crack needs to be a hot-repair (such as hot tar).

Possibility of getting FEMA funds for a storm shelter. No update.

Arnie Kroupa has paint to touch up the entrance sign – will do the work as well.

Picnic shelter: The plan is to go back to the original designer of the expansion plans (Bob Peugh) to reduce the number of posts to be similar to existing structure. Will not be able to match existing shelter perfectly (significant structural differences in the roof), but will be trimmed similarly.

Harbor committee had a work party with a good turn out. Note: The circuit breakers are not labeled correctly – this will be corrected at the next work party.

Vandalism/Thefts incident of May 2009 – status (Reynolds) Hearing is planned for next week for one of the defendants. The other defendant has changed attorneys and his hearing is in August. People that were vandalized receive letters notifying of hearings.

Workman's compensation – coverage in place

ADA - Compliance check update:

Auditor for ADA issues will be brought in June 17 to proactively survey possible ADA improvements. This is a self-assessment – not a KDWP assessment. However, we are expecting a credit on our license fee next year to cover the cost of the audit. See additional notes below under the concessionaire's license.

ADA Complaint update:

Appearance to KDWP that this was a “whistleblower” event and there was retaliation involved. Further information on the issue was provided to KDWP about the offers of resolution (including reinstatement) made to the person making complaints.

The BOG fielded many questions from a guests about why this individual was expelled. The subject was covered in detail in the meeting.

A summary of the face-to-face meeting with this person (two weeks ago) was provided, including an overview of the verbal offers made to this individual.

A proposal was made to send a letter in writing to this person's lawyer asking them to have the person reapply for membership with fewer conditions than provided in the face-to-face meeting. A draft of the proposed letter was provided. Some recommended words for addition were provided for dropping all claims. Paul McCausland provided an updated draft to cover these words.

A suggestion was made to provide a letter that by signing the release (words from Paul McCausland) the person agrees and is therefore reinstated as a member without reapplying.

Concerns about how all this will tie into the KDWP desires for proper handling of this issue. The proposal(s) will need to be run by the insurance companies and the KDWP. **Motion** to approve the wording that has been drafted in this Board meeting for review with the insurance companies and KDWP. Once acceptance by these groups is received, the letter would then be sent. **Approved.** No votes against, no abstaining votes.

State of KS Water Trails discussion

**Motion** was made to have Government Liaison (Gene Nold) inform the KDWP that we will not be submitting a proposal for grant on this project this year. **Approved.**

There were concerns from some members about not getting the emails (that included a summary of the concept/KDWP requests) that was sent to members.

Concessionaire's license update

WVSC Board approved a draft version of the license in a review on May 25th. This was submitted to KDWP. Another draft has been received with changes. The State has added that they can survey the public about the club. Some items have been struck from the original draft.

The paragraph that could imply ADA non-compliance will not be struck because it is included in all contracts (WVSC is not being singled out). The contract will not be approvable by Corp of Engineers without this new standard wording. Our plan to bring in the auditor will contribute strongly to the plan requested in the license. **Motion** to approve keeping the words in for this paragraph (X5). Seconded. **Approved**

Essentially all other wording we recommended was incorporated by KDWP.

Comments about rude receptions that some visitors have received from members. This needs further improvement.

**New Business**

Need to start looking for a location for the annual Christmas party. Need to have it firm by August. Debbie Chambers is to pursue a location.

**Member Concerns**

Dry storage weeds: Still tall. They are being sprayed (kills existing weeds, does not sterilize the ground). Progress was indicated. This effort is a lot of work.

James Rix: Handed out the letter that KDWP sent to Mike Hand. The letter makes it appear that STEP made proposals and agreements on behalf of WVSC when not directed by the board, and maybe was using the storage box as a means to this end. Gene Nold and board members disagreed with the appearance –

this wording was completely from the KDWP and not initiated by STEP/WVSC. James and some members have put together a proposal as an alternate to the Water Trails idea, but since that proposal has been voted down, James said that they would have to regroup on the proposal. The proposal was handed out anyway. Board direction was to have James meet with Gene Nold to work out a two-sided, win-win view.

Question about serving alcohol at socials: The Club cannot provide alcohol at socials, even if it is free. Anyone sponsoring a party on behalf of WVSC is discouraged from sharing alcohol openly because it could easily have the appearance that the Club is providing alcohol. Also, the club will not police the KDWP alcohol laws (it will be up to individual members to police their own compliance with the park rules).

It was requested that a firm number of "votes" be determined so that if someone wants to gather 1/5th of votes for a petition the acceptance level is known. (The number has since been determined to be 198 voting members. 20% of this is 40 votes (39.5)).

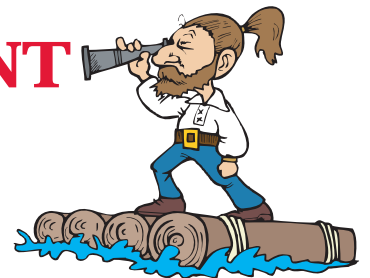
