The water is turned off and the systems have been drained.


Please do not use the sink or rest rooms. The water heater and the sewage pumps are also turned off.

- Call to Order at 7:06 p.m. by Commodore Brown.
- Quorum is present.
- September Meeting Minutes approved as written.

Treasurer's Report:

- Paul Schye presented the Treasurer's Report.
- Work Credits are due by October 15. Question from Treasurer concerning Work Credit for STEP. Consensus is that STEP Board of Governors will receive Work Credits.
- A new Dry Storage Lease Agreement was presented by the Treasurer. A motion to approve the new Dry Storage Lease Agreement, as amended, passed.
- 2012 Proposed Budget presented. The Budget was discussed, amended and motion to approve passed. A balanced 2012 Budget will be presented to the membership at the Annual Meeting. The Proposed 2012 Budget will be sent out to the membership with the Annual Meeting notice and agenda.
- The Board discussed the need for the 2012 Long Range
 Planning Committee to look at Club needs versus revenue.
- The Treasurer's Report was accepted.

Unfinished Business:

- The status of possibly porting the Activity Center weather station information to the Internet was presented by Gary Mackey for Bill Fonger. Bill Fonger will continue to investigate and plans to bring information and cost to the December Board Meeting.
- Proposed By-Laws change: David Bonifield and Greg Rincker presented a proposed By-Law change. After discussion and

amendments, the following proposed By-Law change will be presented to the membership at the Annual Meeting, in accordance with Article XI Amendments of By-Laws:

Article X

RESIGNATIONS AND EXPULSIONS POWER OF BOARD TO SUSPEND OR EXPEL:

The Board of Governors at any regular or special meeting may suspend or expel for cause, in addition to the provisions heretofore made, any member of the club, such action to be by a three-fourths (3/4) vote of the Board of Governors. The Board may immediately suspend a member if the Board considers the cause to merit immediate action.

If a member is to be considered for expulsion, the Board of Governors shall give notice in writing stating the reason for proposed action to the member no less than two weeks prior to the meeting at which the action is to be taken. The Board shall provide the member an opportunity to respond and present evidence. The meeting shall be open at the member's request. A member who has been suspended or expelled shall not be allowed to visit or use the WVSC facility either individually or as a guest.

New Business:

- Government Relations: The Club has received a request from the Butler County Sherriff's Department that we again support the Butler Camp 2000 in 2012. The proposed 2012 date is Wednesday June 6th. Motion to approve the request passed.
- The WVSC Annual Meeting will be Saturday, November 12, 2011at the House of Schwan (Pot Luck dinner to follow).
 Committee reports need to be submitted to the Secretary by November 1.
