Call to order 7:02 – opening remarks

Corrections to Minutes of August Board meeting?

Accepted as written.

Treasurer's Report – September 2010

Application for a new (previous) member. Rick and Chris Brandorff were approved for membership.

For FY2010, the club as a whole has come in significantly under budget (means we have money left over) although STEP will come in with a slight loss.

Draft budget for 2011 presented (was prepared by Treasurer and Finance Committee). Discussions were held and the budget will be updated. The budget is very close to last year's budget. Picnic area expansion, and Picnic Tables, and ADA improvements will be put in as their own line items. Money will be put in the Activity Center budget to cover a new refrigerator (see below). A **Motion to approve** once these updates are made. **Motion was Seconded. Approved.**

Approval by board means that it can now be presented to the general membership (at the annual meeting) for final approval.

Old Business

ADA - Compliance report update

- i. Policy changes per assessment

The ramps that are currently on the STEP storage buildings are not required.

Two articles were provided for review that apply to the use of STEP boats and will be attached to these minutes.

The first article on access will be presented in the *Windword* as a notice now and in the spring as a

reminder. The second article on policy will be published as a new Section 8 in the Rules and Regulations. **Motion to approve. Seconded. Approved.**

- ii. Concessionaires license

KDWP is still trying to determine if we should be using a Special Use Permit or a Concessionaires license. We have had a Concessionaires license, and the intent has been a longer term agreement than a Special Use Permit. There are also some small wording changes to iron out. Action on this remains with the KDWP.

- iii. Agreement with El Dorado Lakes KDWP

WVSC is still in agreement with what needs to be done for ADA. Discussion with El Dorado KDWP and the Wichita office confirm these items do not need to all be done by the end of 2010.

Report from Gene Nold: Gene Nold attends Friends of Eldorado meetings. At a recent meeting, the KDWP presented some slides with very complimentary comments about WVSC, and does not think that we could have a better relationship with them. Most lakes do not have this good of relationship with similar clubs.

The BOG expresses gratitude to acts of assistance that WVSC members have provided to non-members at the lake.

Committees – Liaisons and Chair positions and reports?

Lights on the committee boat are working now. The anchor windlass has been removed for repair under warranty.

STEP proposal - James Rix / Paul McCausland

A meeting was held Oct 4 by a small group to address the confusion about STEP, how it relates business-wise and otherwise with the club, and how STEP is operated. Several suggestions were assembled for improving the communication and reduce the confusion in the future.

Between 2002 and 2003, Youth Sailing (now STEP) was dropped from the by-laws as a standing committee (apparently in error). A **Motion** was made to propose to the membership to add this back in with the current name, STEP. **Seconded. Approved.**

WVSC POLICY

The ADA auditor suggested that a policy be posted for use of the STEP boats. The following wording was accepted by the BOG for this policy and will be posted at the STEP storage buildings. Additionally, the policy will be added as a Section in the WVSC Rules and Regulations for member reference.

Access to STEP Boats and Equipment

STEP boats and equipment may be used by any member of WVSC for the purpose of continuing to develop their skills and expertise in the sport of sailing. Pre-requisite for using the boats is successful completion of the centerboard class or attending an orientation session both of which are provided by STEP personnel. Members are limited to using only those boats for which they have successfully completed one of the above sessions. One orientation session is scheduled each spring and is free of charge. A member may be checked out in any of the boats at other times by arranging an individual session with the STEP Director or his designee. A \$40.00 fee will be charged for these individual sessions. Upon completion of one of the above, the member has access to the boats for the remainder of the sailing season. The centerboard class or orientation session is required each year before boats can be used.

Boats may be reserved by calling the STEP Director or his designee and reserving a specific class of boat for a specified time. Boats may not be used at any time during the regularly scheduled STEP sessions.

Anyone with disabilities who needs help in accessing the equipment, rigging and launching the boats, please request assistance with the Director or his designee when making the reservation. The Director will then arrange for personnel to be onsite to help the member with his needs.

A Motion for acceptable wording in the By-laws was made as follows:

The STEP committee's purpose and function is to assist the STEP program in carrying out its mission, consistent with its non-profit 501c3 status. The members of the committee shall be the STEP board and a WVSC Board liaison appointed by the commodore who is not member of the STEP board.

Seconded. Approved.

Add to the list of member types a "Provisional" member as follows:

A person that joins the STEP program is a Provisional member through the end of that fiscal year, with club access privileges, but excluding voting privileges.

To be presented to the membership for approval. **A Motion was made to approve. Seconded. Approved.**

STEP By-Laws and handbook to be put on the website. This has been done.
