

Commodore's Remarks

Loved the Regatta and the Social afterwards. Excellent job to all who took part in the planning, prepping, and operations to make it such a success. I have heard nothing but compliments and "when will we do this again?"

July Meeting Minutes Approval -

July minutes were recorede by Julie Barth as Secretary Pro-tem. Paul Schye moved approval; Doug Albro seconded. Minutes were approved.

Membership Concerns -

Group discussed Mike Reynolds' application for membership with WVSC. Preston Brammer noted that he has talked with Mike. The transfer of boat ownership is to take place tomorrow, 18 August. Thus, the boat being launched is owned by Mike R. BOG members noted that final membership approval would be pending payment of membership and fee's. Noted that the bylaws do not allow the transfer of slips (via some payment arrangement). The slip for the boat was gifted, and so, free of the bylaws restriction. Mike is willing to participate on a committee.

Paul moved that "The BOG accept Mike Reynolds for membership, pending the funding stipulations previously mentioned. Chris Proudfoot seconded. The motion passed.

New Business -

- The Hydro Hoist is being relocated within the dry storage and is being worked on. No member present is certain who owns the pontoons that are being stored in the dry storage area. Noted that Gene Nold may know. A member is interested in using the pontoons with the Hydro Hoist. Precedent suggests that this should be some type of sale to a highest bidder. We can place an auction ad with the newsletter and at the clubhouse. Stipulation that the "winner" is responsible to remove any debris.
- Issue with new flags members have noticed they don't look good. We spent \$80, but agree that they did not last long. (\$12 per flat). Discussion earlier in the year had noted that Kent Carter was a possible source for replacement flags.

- 3. Racks and Pads for small boat "beach" Investigation shows that the pads are actually glued down, so if taken up, the residual glue will be unsightly. The pram racks are dilapidated, need to be taken down and disposed.
- 4. Ardie Condon indicated that they have an extra dock ladder that they will donate to become an additional "rescue ladder". The group suggested locations on the 'A" side of the dockage. We will get Charlie Volk to install this.

Long Range PlanningTroy OberlyAustin Bayes, Chris Proudfoot.Chris reported on his visit with Park Manager about the proposed SailS-hare program.Indication is that the State must sign off on anything that we sell here at WVSC. The State mustget a cut of all sales (expecting sales tax as well).The manager noted that State Park revenueis way down; they are looking at all of the State Park agreements to improve this deficit.proposer, Bruce A., would need to make a concierge agreement with the State of Kansas, proveinsurance, legal status etc.This seems like more effort that Bruce is interested in.Would want to see much more than 10% of the income to make it worth their management time.As a long range plan, this is pretty dead in the water.

As a side takeaway, the WVSC current agreement expires in 2030. We should be prepared to see const increases and perhaps other stipulations.

Powerboats Preston Brammer Bart Peace We have a connection for the motor for the committee boat. Preston noted that the Wednesday group have been keeping the gas tanks full. Stuart indicated thwat we will need some gas in tank for the upcoming week's activities. Preston will bring some. The slip that the committee boat currently occupies is not currently rented. In response to member concerns about water in the Whalers. This was from the week's rainfall and not from leakage. (Should be dry by now.) Harbor Kevin Welch Charlie Volk Has anyone noticed any boards that need replacement? Please advise. Electrical boxes were recently checked and found to be operational. A water leak has been fixed. The water spigots out at the slips seem to have adequate pressure; this in contras to comments indicating that clubhouse pressure was low. Water pressure indoors seems OK now. We are not sure if this was a kitchen issue of noted in bathrooms as well. **Activities Center** Paul Schve Doug Albro Paul Schye noted that the oven is not working correctly. Paul will get a new element. Membership Ardie Condon Katy Brammer Membership activity was discussed earlier in these minutes. Old Business -

Group questioned whether a conclusion reached regarding WiFi and cameras? A \$99 per month for second tier coverage. It would be \$75 for a first tier package.
